Chair reported from the Steering Committee that a fall semester break will piloted for this upcoming FS' 2020. This will be a three-day break in early November for undergraduate students. Graduate students will not be included in the pilot program for the fall, but there is a possibility for inclusion in the future.

Chair also announced that the committee will be fielding many requests for changes during the upcoming meetings as a result of the required changes for the new Student Information System. Because of the anticipated high number of change requests, some processes may be implemented to help mitigate the workload for the committee.

Chair updated committee on the status of the Masters' of Science and Data Science proposal. The two participating units are working on a memo of agreement.

4. Remarks from the Dean of the Graduate School (Jeitschko)

Dean announced that there has been a postponement of the implementation of the new student information system (SIS). The technical implementation is still proceeding and the requested changes to programs should still move forward.

Dean also discussed continued efforts from the Graduate school regarding mentoring. This will be discussed at the Graduate Director summit planned for January 31st. There will also be events around campus in regard to mentoring including workshops designed for specific colleges. Units should begin to implement mentoring policies. Additionally, Dean announced that the Graduate School will continue to engage in assessment and program review.

5. Remarks from the COGS Representative (Abel)

There will be a COGS meeting on January 22nd and will be focused on the travel policy, including a consideration of the addendum from the Research Policy Subcommittee regarding postdoctoral scholars. The meeting will also consider mentoring guidelines.

Research Policy Subcommittee (T. Hogan)

Provided an update on travel policy. The addendum to the travel policy proposed by the subcommittee will be discussed at the COGS meeting on January 22nd. The subcommittee will wait to get feedback from COGS as well as other units and the full committee will consider the proposed changes again during the February meeting.

Graduate Instruction, Employment, Mentoring Subcommittee (T. Sharkey)

Committee looked at two documents concerning mentoring produced by the Graduate school, Foundational Values for Graduate Student and Faculty Mentoring Relationships and MSU Guidelines for Graduate Student Mentoring and Advising, and met on January 2nd to discuss. The committee provided a report on the mentoring documents which recommended that the documents should be endorsed; however, there were issues that they thought the larger committee and the graduate school should consider. The six issues are detailed in the subcommittee report.

The subcommittee recommended that the full committee endorse both documents with the consideration of the six points detailed in their report.
